Introduction

The Scout Association holds the copyright to some 400 resources, including most of the works of the Founder, Lord Robert Baden-Powell. Quite often, The Association receives requests from Members of the Movement and the public to reproduce this material. We operate a fair and open policy aimed at promoting the use of our resources while protecting our intellectual property rights.

What is copyright?

Copyright is the exclusive right given by law, which protects the original work of an author, artist or designer. Under the terms of the Copyright Designs and Patents Act 1988, the following can be described as copyright works.

- Original literary, dramatic, musical or artistic works (including computer code)
- Sound recordings, (including CD's and CD-ROMS), films, broadcasts or cable programmes
- The typographical arrangements of published editions.

Material that is protected under copyright is the intellectual property of the copyright owner and cannot be reproduced without permission from the owner.

How long does copyright last?

The length of time a piece of work is protected before it can be freely used without restriction, is life, plus 70 years. This period is described as the 'term of copyright'. A book therefore does not enter public domain until 70 years after the author's death.

The Association's rules

The following rules on copyright are extracted from *Policy, Organisation and Rules*, (The Scout Association, 2002)

- No organisation may reproduce any part of any publication, the copyright of which is vested with the Association, without the prior written permission of Headquarters.
- Scout Executive Committees may authorise the reproduction of extracts suitable to meet a specific purpose in the production of material required to further their work.
- The copyright of works, which are vested in the Association, may only be licensed or assigned by Headquarters.
- No organisation or individual may state that any item has been approved, in content, quality or otherwise, by the Association without the prior written permission of Headquarters.

Reproducing material for commercial use

If your request is to reproduce part, or the whole of a publication for financial gain, or if you wish to use an extract in a publication which will be sold, then this is classed as commercial use. If this is the kind of permission you require, please use [Copyright request form 1: Publishing](#)

If permission is granted, two copies of the title will be required for our archives on publication and the following text must be prominently displayed in the list of acknowledgements:

'Reproduced by permission of The Scout Association. License number 0000'

(enter designated number)

Other conditions may be specified on an individual basis.

Translating copyright material

Under the Berne Convention and the Universal Copyright Convention, copyright work is also protected overseas.

If you wish to translate, reproduce and sell material that is owned by The Scout Association, then you must also make a formal copyright request. Please use [Copyright request form 2: Translation](#)

If you wish to translate an extract from a book, CD-ROM or any other resource, you must complete this form. Please remember to include information about any additions, amendments or abridgements that you plan to make.

If permission is granted, two copies of the title will be required for our archives on publication and the following text must be prominently displayed in the list of acknowledgements:

'Translated and reproduced by permission of The Scout Association. License number 0000'

(enter designated number)

Other conditions may be specified on an individual basis.

Copying material for internal Scouting use

You may reproduce short excerpts from material owned by The Scout Association *for genuine Scouting use*, without seeking written permission from Headquarters. This material however, may not be sold or distributed in any way.

If you are using copyright material for this purpose, please also display the following text:

'Reproduced by permission of The Scout Association.'

The exception to this rule is electronically published materials (such as CD-ROMs). These may not be reproduced or otherwise duplicated for any purpose without prior written permission from Headquarters. To request permission, please use [Copyright request form 1: Publishing](#)
