## Introduction

This is the second edition of a factsheet explaining Ordnance Survey Map Reproduction. All changes from the first edition are highlighted by a side line. Further editions will be published in the light of experience or advice from Ordnance Survey. The publication of future editions will be notified in Scouting Magazine, Talking Points and the Activities Newsletter.

## Reproduction for Educational Purposes

The Scout Association is in possession of an Educational Licence that allows Members of The Scout Association in Great Britain and Northern Ireland to copy Ordnance Survey Maps.

This licence allows:-

- the copying of mapping for educational, research or teaching purposes.
- the use of digital mapping and the production of paper copies for education, research or teaching purposes up to A4 paper size, at a scale of 1:25,000 or smaller.
- copying the whole large-scale map sheet, that is, 1:1250 scale, 1:2500 scale and 1:10,000 scale.
- making copies larger than A4 paper size of small scale mapping if the copies are black and white or the map has been redrawn.
- Each reproduction must carry an acknowledgement, the usual form is;-

Reproduced from the (year of publication and name and scale of map), map by permission of Ordnance Survey on behalf of the controller of Her Majesty's Stationary Office

This licence only applies to education, research or teaching of Members of The Association under the age of 18 years.

An Education Licence does not allow:-

- the copying of mapping as a location map in a prospectus, brochure or any other publication.
- using mapping for any purpose other than education, teaching or research purposes.

## The Reproduction for Other Purposes

A separate licence is required if there is a need to reproduce an Ordnance Survey Map as a location map in a brochure or prospectus.

Counties, Districts, Groups or Campsites that wish to use extracts of Ordnance Survey maps in promotional material will need to contact Ordnance Survey and ask for a copyright licence application form. Ordnance Survey will bill the Counties, Districts, Groups or Campsites involved directly.
